## MESSAGE FROM THE DIRECTOR

2015-2016 has been another busy year for the Agricultural Health and Safety Network. First of all, we are delighted to welcome a new staff member, Miranda Dziaduck, to the team. Miranda's background is in psychology and she recently completed her Masters in Public Health at the University of Saskatchewan. She and her husband farm near Yorkton. Welcome Miranda!

We are pleased about our progress along our 5 year strategic plan. The plan identifies targets and goals in four major areas: (a) funding and partners, (b) reach and visibility, (c) activities and outputs, and (d) effectiveness. Recently, CCHSA and the Network have collaborated with the Canadian Agrisafety Applied Research Program to develop information materials related to the two research projects funded by the program. The projects are in the priority areas of low-cost rollover protective structures (ROPS) and animal housing environments. Bulletins and other information pieces on these proj-

ects are being created by the Network and some of them have appeared in the Network News, with more to come. We are also excited to have partnered with the Agrisafe Network in the US on a three year project to provide OHS programs to agricultural colleges and training programs, with sponsorship from CHS and 3M Canada.

The Network has hosted 18 workshops and safety presentations in the last year across the entire Province, 13 health clinics with at least one in each division, and attended a number of tradeshow and meetings highlighting our activities. Saskatoon hosted the annual Canadian Agricultural Safety Association conference (CASA) in October 2015 and CCHSA and the Network played a significant role in various aspects of the event. We have also developed a new resource focusing on child safety on the farm, as well as a new and very popular fact sheet on grain entrapment. There's much more to say, but you'll have to check out the rest of the report!

As always we couldn't do any of this without the support of our member RMs, SARM, the Ministry of Agriculture and partners like CASA and industry. On behalf of the entire Network team, thank you! Let's all do our part to make this year a safe, healthy and productive one.

# Canadian Centre for Health & Safety in Agriculture - CCHSA Research and the Network

CCHSA was founded in 1987 and is located at the University of Saskatchewan. The Network was founded 2 years later. Research guides the Network's focus on various agricultural health and safety concerns. CCHSA's researchers and extensive network of international researchers and collaborators investigate a broad range of topics that can potentially impact the health and safety of Saskatchewan farm families.

Some of the research projects at CCHSA include:

- Saskatchewan Injury Cohort - examining the types of injuries and fatalities that are occurring in populations of Saskatchewan farmers
- Saskatchewan Rural Health Study - respiratory health
- Low back disorder-related pain and disability experienced by Saskatchewan farmers
- Dementia care: Rural and Remote memory clinic
- Saskatchewan First Nations lung Health Study
- Asthma diagnosis in Saskatchewan children

## The Agricultural Health and Safety Network

### History

The Canadian Centre for Health and Safety in Agriculture (CCHSA) partnered with the Saskatchewan Association of Rural Municipalities (SARM) and six Rural Municipalities in 1988 and founded the Agricultural Health and Safety Network with the mission to improve health and safety on the farm through education, service, and evaluation research. This organization is now in its 28th successful year and is providing occupational health and safety services to 217 RMs that are members of the Network, with a mailing list of approximately 30,000 farm families. The Network represents an agricultural health and safety program that is unique to Saskatchewan and Canada.

### Funding

The Network is funded through RM fees, the Saskatchewan Ministry of Agriculture, the Canadian Center for Health and Safety in Agriculture and other grants for specific projects.

### Membership & Recruitment

The current membership of the Agricultural Health and Safety Network is 217 RMs. Each of these RMs pay an annual fee of \$3.75 per active farm family to benefit from the Network resources and services. The RM membership fee is currently capped at \$1200 per RM. The partnership that member RMs provide is truly the foundation of the Network and helps to attract additional resources to better serve Saskatchewan farmers, their families and their workers.

In an effort to increase Network RM membership an annual recruitment package is mailed to non-member RMs. In addition this year visits were made to RMs council meetings to encourage and promote Network membership.


Support of the Network helps us continue a unique program that can benefit collectively all farm families and agricultural workers in Saskatchewan. Thank you for your support!

2. **Animal Housing Environments**



## NEW! INTERNATIONAL PARTNERSHIP

The Network is excited to have joined a three year national project partnership with AgriSafe Network (US), with sponsorship from CHS and 3M Canada, to provide occupational health and safety programs to agriculture colleges in Saskatchewan and Alberta.

Our goal is to empower students to recognize agricultural health and safety risks associated with their work environment and become their own health advocates. Based on students' agricultural exposures, we will equip them with the tools that will help them stay healthy and safe in their work environment. This tool kit includes a combination of an interactive lecture, demonstration of personal protective equipment, health screenings and review of appropriate resources. Students will each receive a personalized fit 3M PPE take home startup kit.

This year we have focused our efforts on program development and promotion which has included: creating a logo for the program, a program information brochure, a customized curriculum options document, webpage development, program promotion presentations and adaptation of the US program to Canada.

The first program delivery is planned for April 2016 at the University of Saskatchewan. For more information contact the Network.

## Reach and Visibility

The Network partnered with Saskatoon Media Group CJWW 600 radio to create and deliver a series of “Think Safety.... Be Safe” farm safety messages that aired during seeding and harvest 2015. **“Remember to always think and practice farm safety.... to keep yourself, your family and workers safe every day”** was the common message that was presented in a variety of 30 second messages that addressed safe play areas for children, communication on the farm, taking care of the farmer during long work hours, equipment safety and moving farm equipment on the roads. Plans are underway to continue radio messaging with consistent farm safety messaging to reach more farm families this upcoming year.

Network staff participated in numerous interviews with radio, print media and independent magazines on a variety of agricultural health and safety topics primary during the seeding and harvest seasons. This included a Harvest Safety segment on CTV FarmGate in the fall of 2015.



# SARM Scholarship

In 1995, the Saskatchewan Association of Rural Municipalities (SARM) actioned off the first copy of its history book “The Building of a Province: Commemorating the 90th Anniversary of the Saskatchewan Association of Rural Municipalities.” This auction netted the sum of \$2,600 which the SARM Board of Directors contributed to the Canadian Center for Health and Safety in Agriculture (CCHSA). These funds initiated the SARM 90th Anniversary \$1,000 Student Scholarship in Agricultural Safety and Rural Health. The Founding Chairs Program at CCHSA now maintains the scholarship.

This year two scholarships of \$1500 were awarded to grade 12 students, *Darby Chappell* from Langham, RM of Corman Park, # 344 and *Emily Wushke* from the RM of Willowdale # 153. Students were asked to submit essays about (a) *The importance of safety and health on our farm* or (b) *Safety and health hazards on our farm*.



*“A person should not only plan for safety, but also for general wellness. Within our family, we take pride in how organized and efficient we work. Our family is quite athletic, and sports oriented; staying active allows us all to take a break from work and focus on fun or activity. We also stop equipment for lunch breaks even if the meal is brought to the field. This allows all workers in our family a short break to ensure fatigue is controlled. Before leaving our house, each worker grabs a water bottle/jug of water to ensure hydration is maintained. While working hot summer days, every tractor is equipped with air conditioning to help us stay cool to prevent heatstroke. During the winter months every worker is provided warm working clothing to avoid frost bite, and to ensure workers don’t get cold during long tasks. As simple as it may be, working outside allows some noticeable health benefits for farmers.”*


*“Stress is another major concern with farming that can cause numerous casualties. Some may not be aware, but stress can cause serious heart problems, including heart attacks, strokes and hypertension. Farmers deal with broken-down equipment, fluctuating prices for their commodities, and the biggest worry of all, Mother Nature. Farmers have a constant worry about what will happen after the next storm; if their crops will survive or be destroyed. Many times, farmers*

*find themselves looking at excellent crops that are producing very well and will soon be ready to hay or combine until, a few days later, a big storm comes and wipes everything out. Crops provide food for communities and income for families, and this is why families find themselves in great deals of stress, worrying about bills and what will happen next. Stress is more dangerous than people realize and therefore must be taken very seriously. These health issues prove that there are not only physical disadvantages to being a farmer, but mental ones as well, and every little possible effect must be taken into consideration when planning the safety of the farm. The farm is only as safe as the owner and the people living and working on it make it.*

Health Clinics for Farmers  
Empowering Farmers to Enhance Their Health



ONE2ONE Health Clinics for Farmers offer the unique opportunity for farm families and farm workers to meet with a trained agricultural health nurse in a confidential environment for a health check tailored to their agricultural exposures and risks. These clinics are offered to Network RM members in the form of either a Respiratory Health Clinic or a Hearing Loss Prevention clinic that is hosted in RM.

Farmers also have the option to book an appointment for hearing, or lung function testing at the ONE2ONE Network Clinic located at the Canadian Centre for Health and Safety in Agriculture (CCHSA) on the University of Saskatchewan campus in Saskatoon.



The ONE2ONE Health clinics are focused on empowering farmers to enhance their health. The clinics offer the opportunity for farmers to have a personal confidential health screening focused on their occu-

pational exposures. Participants receive current health information and education aimed at reducing agricultural exposures. Common health concerns such as blood pressure, diet, exercise, stress, and sleep are addressed. Resources and any necessary referrals are offered to optimize personal health and safety.

We are looking forward to opening our **New CCHSA Audiology Lab** in summer 2016. The ONE2ONE Hearing Loss Prevention Clinic for farmers will be set up in this lab to offer audiometric testing in a sound booth complete with new **hearing protection fit-testing**. In addition, we will be able to offer the hearing protection fit-testing to farmers remotely when clinics are delivered in the RMs.

The Network also offers clinical and outreach learning experiences for nursing students.




