- A completed **CIHR Project Biosketch CV**.
- Two letters of reference using the **Founding Chairs Supervisor/Referee Report Form**. One of the two reference letters must be from the trainee's current supervisor. For Postdoctoral trainees in the first year of their position, one of these assessments should be from their Ph.D. supervisor.
- Original or copies of official transcripts for all University studies undertaken.
- Proof of current or pending Postdoctoral/Clinical Fellow position.
