

Understanding COVID-19 Vaccine-Related Ageism on Social Media

INTRODUCTION

- During rollout of COVID-19 vaccines, older adults were often prioritized for inoculation in efforts to reduce mortality.
- However, this prioritization may have contributed to ageism, particularly with the limited supply of initial COVID-19 vaccines.¹
- With an average of 500 million daily tweets, X (formerly Twitter) provides a timely means to examine vaccine-related ageism.

PURPOSE

• To understand COVID-19 vaccine-related ageism on X during the pandemic to inform future vaccination awareness campaigns and policies.

METHODS & ANALYSIS

- Tweets gathered on X (social media platform) using Twint application in Python from Dec. 8, 2020 to Dec. 31, 2021.
- Search terms included range of 3 concepts: ageist labels (boomer, coot, etc.), vaccines, and COVID-19.
- Filters excluded irrelevant tweets (3,677), remaining 1,369 tweets analyzed by coders.
- Thematic analysis used to identify key patterns and themes in the data.

RESULTS: MAIN THEMES

- i. Blame and Ageist Aggression: "Wish Covid-19 could be modified such that it will only w*pe off boomers regardless of vaccination."
- ii. Misinformation and Mocking Content: "All boomers do on Twitter is spread covid misinformation or blame young people for the state of things while refusing to get the vaccine young people can't have..."
- iii. Ageist Political Insults: "Think about Biden's when considering his COVID mask/vaccine policies ... This dementia addled old coot has no idea what ramifications his partisan actions can/have/will cause."
- iv. Combatting ageism: advocacy and accessibility: "COVID vaccine booking process is awful and not friendly for older adults. We need a much better system."

DISCUSSION

- Although some tweets advocated against ageist COVID-19
 programming, tweets often described issues of hate speech, false
 information, and ageist political insults that contributed to
 intergenerational conflict.
- Further research and targeted awareness campaign strategies are needed to address COVID-19 vaccine misinformation, counter aggressive ageist content, and support intergenerational unity during the COVID-19 pandemic and beyond.
